Dear Honorable Members:

The Erie County Comptroller's Office has completed an audit of the Erie County Department of Central Police Services ("CPS") for the period January 1, 2006 to April 30, 2008. The scope of our audit was limited to departmental controls and oversight of computers and certain related electronic devices.

We performed our audit in accordance with Generally Accepted Government Auditing Standards, and included such tests of records, inquiries, and analyses as considered necessary under the circumstances.

Our objectives were to determine the propriety of inventory records; to inventory computers, including laptop computers, and other related devices; and evaluate internal controls over these items at CPS. This audit examined asset tracking and asset tagging, including the surplus disposal of these assets.

CPS management is responsible for establishing and maintaining a system of internal accounting control. Our evaluation of internal controls disclosed deficiencies that result in a more than relatively low risk that errors or irregularities may occur and not be detected within a timely period.

Because of inherent limitations in any internal control structure, errors and irregularities may nevertheless occur and not be detected. However, we noted certain matters in the internal control structure and its operations which have been reported in this audit.

BACKGROUND:

The Erie County Comptroller's Office commenced this audit in late April 2008 following this office's receipt of a letter from the Erie County Attorney in which it was disclosed for the first time to this office that items were missing at CPS. In her April 15, 2008 letter replying to the Erie County Comptroller concerning a separate management issue at CPS, the County Attorney wrote:

Between late December, 2007 and March 11, 2008, it was discovered that both computer records as well as inventory went missing at CPS. Several independent sources confirmed that the lack of any acting Commissioner of CPS resulted in this tangible loss of County property.

CPS allegedly notified the County Administration, the County Attorney, and the Sheriff's Department of the apparent theft of missing computer equipment. CPS informed our office that it believed the Comptroller's Office did not have to be notified of this event. Upon further inquiry by this office, we subsequently learned that computer hard drives installed in the office and laptop computers assigned to a former CPS Commissioner were missing. During this process we learned that County administration officials and a Sheriff investigator had been looking into this matter for several months. The Erie County Sheriff's investigator concluded his assignment without finding the missing items. It was not the purpose of our audit to find these missing items, and in the course of our inventory we did not discover them.

In addition this office received several anonymous letters via U.S. mail regarding missing computers and other alleged improprieties at CPS. The Erie County Comptroller's Office investigates all allegations and reports of possible waste, fraud or abuse. During the course of our inquiries into the above described matters, the County Attorney and the allegedly acting Commissioner of CPS directed CPS employees not to speak with the Office of Comptroller regarding this matter.

Based upon the above issues, this office announced an audit of CPS on April 23, 2008, and an entrance conference took place on April 24, 2008. Field work began on April 25, 2008.

SUMMARY OF FINDINGS:

Control deficiencies exist in the internal controls over computer inventory. The internal control system is likely to neither detect or prevent errors in the computer inventory, nor prevent misstatements. The findings are based only on procedures observed, not on the entire control system.

<u>INTERNAL CONTROL TESTING:</u>

Our tests of internal controls over inventory at CPS revealed the following significant findings:

• <u>Physical Inventory</u> of all equipment has not been performed since January 24, 2000. Failure to perform a physical inventory at least on an annual basis provides an opportunity for inventory to be unaccounted for and minimizes the probability of reconciling the inventory balance.

- Assets costing \$500 or more have not been recorded consistently since the Systems Applications and Products in Data Processing system ("SAP") was implemented and "went live" in 2004. A complete list of CPS assets could not be obtained from SAP for the period under audit. CPS personnel stated that SAP has not been used to record all assets costing \$500 or more.
- <u>No reconciliation</u> of inventory additions and deletions was performed. The lack of perpetual inventory records precludes the possibility of reconciling physical inventory to recorded inventory. The lack of regular reconciliations of inventory provides opportunities for misstatements.
- Segregation of duties over equipment is weak. CPS has segregated the custody and recordkeeping functions related to computer inventory. The person responsible for receiving computers and applying an inventory number tag does not have access to the inventory records. However, the same person who records inventory transactions has authority to make changes to inventory records, and has access to physical items.
- <u>No authorization</u> was found for items deleted from the department's inventory. The log sheets used by CPS personnel to record inventory additions and deletions do not contain fields to record authorization or transaction dates.
- The source of surplus inventory items discovered at CPS could not be determined. We found inventory at CPS that was not recorded in SAP or other electronic or paper logs. A physical inventory of surplus computers was conducted. Dispositions were found for four of the items. CPS provided explanations for the remaining items.
- No log is maintained for the final disposition of surplus inventory. The County's Division of Purchase ("Purchase") collects surplus inventory from CPS but no paperwork is exchanged at the time of equipment pickups.
- <u>Tests over the existence</u> of laptop inventory revealed that two computers have not been accounted for.
- <u>Physical inventory</u> items were traced to inventory log sheets maintained by CPS personnel. A number of items in physical inventory were not found on the CPS inventory records. CPS provided explanations for all items.
- Physical safeguards over assets are adequate. Laptop computers assigned to police departments within Erie County are placed in lockable mounting brackets within agency cars. The keys are available only to the respective station chiefs and CPS personnel. The CPS building is secure from outside intrusion and cameras are located throughout the premises. Small items such as hard drives, however, are always susceptible to theft.

SUBSTANTIVE TESTING:

The Erie County Comptroller's Office conducted substantive testing that accounted for all CPS computers purchased by the County during the audit period. The testing also resulted in the following findings:

Purchase Orders:

We reviewed 14 purchase orders ("PO's") issued during the audit period for the purchase of computers. Of the 115 computers and servers purchased by the County through these PO's totaling \$209,490, we found that none of these items were recorded on SAP. The purpose of recording asset purchases in SAP is to officially enter the acquisitions to create a means of inventorying and tracking.

All of these items were subsequently located either in our physical inventory, the CPS laptop inventory (largely for computers in police vehicles) or other subsequent confirmations.

WE RECOMMEND that CPS management takes the necessary steps to record all newly purchased items in SAP in excess of \$500.

SAP Inventory:

We generated an SAP asset list for business area 165 (CPS) and eliminated all items on this list that were not computers. Using this SAP list, we further deleted all items located in our physical inventory, all items on the CPS laptop inventory, and the items noted on the inventory log sheets prepared by CPS as being transferred or deleted as surplus. This left a balance of 213 items including desktop and laptop computers that are not accounted for as of May 27, 2008¹. A listing of the items in physical inventory is attached as Appendix A. A listing of unaccounted for items is attached as Appendix B.

WE RECOMMEND that CPS management initiate steps to ensure that going forward all items that leave the possession or responsibility of the department be formally recorded as transferred or surplus and that the appropriate paperwork be retained.

Invoice Payment:

As part of the installation of the telephone communications system at the Public Safety campus, CPS issued an RFP for the purchase and installation of the appropriate equipment. Verizon was selected to install and maintain this equipment.

When the equipment was received, Verizon representatives alone unpacked and installed the equipment. One of the servers was selected to receive a lone asset tag which represented the entire purchase. CPS received invoice number 67231, dated January 17, 2007, in the amount of \$1.5 million for the "provision and implementation of Vesta Meridian Application." No additional detail was provided to CPS as Verizon retained the packing lists. The invoice was paid without knowing what was actually billed for versus what was actually received.

¹ The original purchase cost of these items was \$447,291 and a book value of \$7,991 at May 27, 2008 using depreciation methods described in the Erie County Accounting Manual. The replacement cost of the missing items was not determined.

WE RECOMMEND that CPS require sufficient support documentation from vendors prior to approving any invoice payment.

Erie County Laptop Computer Policy Acknowledgement:

Management of CPS is not in compliance with the Erie County Laptop Computer Policy Acknowledgement ("policy"). The policy requires that laptops are to be signed out to the employee receiving the computer. In addition, the policy acknowledges that the employee agrees not to modify, alter or upgrade the hardware or software without consent.

We found that the policy was not utilized for any CPS purchased laptop. Compliance with the policy would serve two purposes—(1) provide for increased security of the laptop and (2) help ensure the integrity of the hardware and software. During our audit we found that none of the 250 laptop computers purchased by CPS were distributed using the policy. Additionally, the use of the policy could have been a deterrent when a hard drive was removed from one of the laptops in CPS.

WE RECOMMEND that management of CPS initiate the use of the Erie County Laptop Computer Policy Acknowledgement. We recognize the fact that CPS will need to differentiate between laptop computers utilized in-house and those assigned to police agencies or police vehicles, and include such information in inventory records.

THE RECORDING OF FIXED ASSETS IN CENTRAL POLICE SERVICES:

Starting with the County's fiscal year 2002, Erie County has been required to implement Governmental Accounting Standards Board Statement number 34 entitled Basic Financial Statements—and Management's Discussion and Analysis—for State and Local Governments ("GASB 34"). Pursuant to GASB 34, and with the approval of the County's outside auditors Deloitte & Touche LLP, the Office of Comptroller's Division of Accounting tracks individual movable County reportable assets valued at \$10,000 and greater for accounting purposes. GASB 34 also eliminated the need for the presentation of the Fixed Asset Group of Accounts. Since 2005, the Comptroller's Office has disseminated large-value asset reports for departmental verification in conjunction with the County's annual independent financial audit.

Financial reporting guidelines require Erie County to value its assets. Erie County's existing policy on the recording of fixed assets is internally defined by the Erie County Accounting Manual. Since its release in January 1988, the policy has been refined and modified by several memos and electronic mail messages. As a result, the policy now exists as a confusing combination of documents, some of which were not widely promulgated.

The Erie County Accounting Manual requires that any asset with a cost of \$500 or more needs to be recorded as a fixed asset. Items to be consumed in use or assets that have a useful life of one year or less should not be considered assets, but should be considered

supplies. Assets with a cost of less than \$500 can still be recorded on the County's asset system, at the discretion of the using department.

An asset must receive an eight-digit SAP asset number and an inventory asset tag. These inventory asset tags, about the size of a matchbook, have a number printed on them. They have an adhesive backing and are attached directly to the asset, usually in an unobtrusive location. Upon receipt of the item, the receiving department is required to affix an inventory asset tag on the item and to then notify the Office of Comptroller of the item and its asset tag number.

Not every asset is tagged. The policy also states that component units, such as cables, video cards and disk drives should be included in the cost of the primary asset. These items are not tagged with a separate asset number. However, items such as "monitors and printers" should be assigned separate asset numbers because these items may have separate useful lives and can be used with other primary units.

Under the current policy, the department receiving the asset enters the asset information into SAP. According to policy this must be done within five days of receipt. The information that is entered into SAP includes: an asset description, the cost center charged for the item, the asset value, the fund charged for the item, the SAP budget line item charged, the asset physical location and a grant number, if applicable.

To remove an asset with a cost of \$500 or more from SAP, a form must be completed and signed by the department head. The approval of the County's Division of Budget and Management is also required. Once these approvals are obtained, Purchase disposes of the item through surplusing the item or auctioning the asset. The actual change to the SAP system is made by accounting employees of the Comptroller's Office.²

We determined during the audit that the above asset recording, tagging and tracking procedure was not being followed by CPS.

WE RECOMMEND that CPS follow the County policy.

RECOMMENDATIONS:

We recommend that CPS management take the following actions:

- A complete physical inventory now in progress should be finalized.
- All assets in physical inventory with a cost of \$500 or more should be entered into the SAP Fixed Assets module. CPS should inspect the SAP Fixed Assets list to insure that all items were recorded and that no items were entered more than once. A final SAP list of fixed assets should agree with the physical inventory.

² Note: pursuant to the Erie County Administrative Code, to help avoid the appearance of or actual conflict, the Division of Accounting is separate and distinct from the Division of Internal Audit. Both Divisions report to the independently elected Erie County Comptroller.

- Inventory log sheets should be modified to include fields for recording transaction dates and the initials of the person who authorizes a transaction.
- Items placed in surplus inventory should be recorded in a log book. Items taken by Purchase for surplus or auction should also be recorded in an appropriate log, and a receipt for items picked up by Purchase should be signed by CPS and Purchase.
- Segregation of duties may be improved by requiring a person, other than the one maintaining inventory log sheets, to approve additions and deletions from inventory.
- All CPS inventory should be tracked on the same log sheets. CPS currently records inventory on various lists. The current log sheets in use should be modified to include a field to record the location of an asset.
- Laptop computers unaccounted for should be located or deleted from inventory.

AUDITOR COMMENTS:

In the past ten years, Erie County has maintained two separate fixed asset accounting systems. The AIMS asset system was phased out in 1996 when the County deployed the SFG enterprise resource planning system (which had no asset management function). For many years, DISS unsuccessfully attempted to develop and deploy a replacement asset inventory system. Ultimately, the deployment of the SAP enterprise resource planning system in 2004 allowed for asset management, as SAP includes such modules. In addition, during this ten year period, CPS maintained and continues to maintain their own asset records separate from SAP in the form of paper logbooks. The use of various electronic and paper logs makes control difficult.

CPS has the responsibility to perform annual physical inventory verification of their county owned assets. Upon receipt of inventory reports from the Comptroller's Office, user departments will review and correct these reports as necessary to ensure an accurate and complete record of County owned assets. Departments are further responsible for certifying the accuracy of inventory reports on an annual basis, and for returning corrected inventory maintenance forms to the Comptroller's Office for inventory updating. These procedures enable the Comptroller's Office to compile a fixed assets balance for the County financial statements.

WE RECOMMEND that the Comptroller's Office Division of Accounting, the Division of Purchase ("Purchase"), the Division of Information and Support Services ("DISS") and the Division of Budget and Management jointly review, revise and update the twenty year-old Erie County Accounting Manual to reflect developments, issues and changes that make the existing manual outdated.

Letters were sent to the Division of Accounting, the Division of Purchase and to DISS discussing applicable audit findings.

THE MISSING HARD DRIVES AND OTHER MATTERS:

The status of the missing hard drives and any related action or developments in the matter of the missing hard drives is undetermined and County administration officials did not disclose to auditors any details or information concerning that matter or actions contemplated by the administration. Based on information conveyed to this office during our initial inquiry, if those devices are missing and not under County control, there is reason for concern given the sensitivity of the data purportedly on the hard drives.

After initial resistance by the County administration to Comptroller's Office inquiries regarding materials and controls at CPS and the matter of the missing hard drives, as well as this audit, we note that this office received cooperation from CPS officials during the audit.

2007 INCIDENTS AND 2008 COUNTYWIDE INITIATIVE ON FIXED ASSET TRACKING:

In July 2007, concerned about asset management and tracking of computer devices, the Office of Comptroller and DISS developed a new procedure under which DISS agreed to disseminate to the Comptroller's Office a master list of computer assets twice annually. In addition, DISS agreed to continue placing County asset tags on all such devices. In July 2007 and December 2007, DISS provided master lists to the Comptroller's Office Division of Accounting.

In October 2007, public reports surfaced regarding allegations that County computers were missing and DISS could not account for hundreds and potentially as many as 2,000 computers. The Erie County District Attorney's Office conducted an investigation, as did the Federal Bureau of Investigation. After an internal review by DISS, that division later represented that most of the allegedly missing computers had not been misappropriated, but rather, disposed as surplus by Purchase over a three year period. DISS and SAP records did not account for the disposition of these assets. The Comptroller Office's Division of Audit and Control examined DISS records and determined that DISS recordkeeping was so poor that a proper inventory was difficult to attain.

Immediately following this incident, the Comptroller's Office contacted DISS and Purchase and the County's SAP consultants and began to develop a process to improve the lower-value asset management system in order to better account for assets valued under \$10,000.

In early 2008, prior to the reporting to this office of any issues or problems at CPS and the commencement of this audit, the Office of Comptroller, County Executive, Purchase and DISS recognized that countywide and departmental understanding of and compliance with the Erie County Accounting Manual provisions regarding asset tracking for items valued under \$10,000 continued to be poor. While departments had been complying with provisions requiring asset tagging and asset management for items valued at \$10,000 and

greater, there was poor internal compliance and reporting for assets valued between \$500 and \$10,000.

To address this deficiency, and mindful of the 2007 incident, on April 9, 2008, via memorandum, the Comptroller and County Executive jointly informed all County departments, agencies and offices of a new asset tracking initiative. Under this initiative, all County entities would physically identify and asset tag all assets valued at \$500 and greater and report that data to the Offices of Comptroller and Division of Purchase for uploading of asset data into SAP. This initiative is scheduled to be completed by June 30, 2008.

In addition, pursuant to a memo dated March 4, 2008 from Purchase and sent to the SAP materials management group (which includes all departments), assets valued at \$500 or more are required have an asset number before a purchase requisition can be approved. Prior to this memo, an asset number could be obtained after the asset arrived. If an asset arrived, and was not tagged or entered into the SAP system, the Comptroller's Office would be unaware of this asset.

RESULTS OF EXIT CONFERENCE:

An exit conference was held on June 2, 2008 with the acting CPS Commissioner and members of his staff, and the Erie County Attorney. The contents of this report were discussed.

In accordance with the County's Audit Response System and Procedures, we request that the acting CPS Commissioner prepare a written response to our office and the County Executive concerning the findings and recommendations. A draft of this written response should be submitted to the Division of Budget and Management for review and approval prior to its submission to the County Executive. The final written response should be submitted to our office and the County Executive by June 19, 2008.

We further request that the acting CPS Commissioner forward copies of the response to the Erie County Legislature and the Erie County Fiscal Stability Authority by June 19, 2008.
