APPENDIX TWO

LUNDINE COMMISSION

In April of 2008, a report was released by the New York State Commission on Local Government Efficiency and Competitiveness (the "Lundine Commission"). This commission was charged with examining local government, with an eye to making local entities more "affordable, accountable, democratic and competitive." The Commission made several observations and recommendations on fire protection in New York State. Rather than repeat that work, their findings are presented here. The Lundine Commission questioned the large number of fire districts and fire protection districts in New York State and asserted the need for a more thorough analysis of fire protection. The Commission reported:

"Our research on fire protection revealed many unknowns about a service that has been around since bucket brigades and horse-drawn pump wagons were the norm. Because of the changing nature of fire protection, dwindling numbers of volunteers, and increasing costs of purchasing and maintaining equipment, we believe it is time for a comprehensive statewide review of how fire protection is provided. With better information on costs, geographic service areas, types of companies and departments, response times and results – localities could better evaluate their relative situation and options for reconfiguration."

We agree with the Lundine Commission's recommendation and so does the Onondaga County Executive. In early March 2010, Onondaga County Executive Joanie Mahoney announced in her state of the county address that she had just directed her emergency management department to work with the fifty seven suburban fire departments in Onondaga County to publicize response times of all those fire services as part of her new effort to promote consolidation of fire services in that county. In her state of the county address, Ms. Mahoney said that Onondaga County residents could no longer afford to pay for 57 separate suburban fire departments and that consolidation needed to be studied and considered as a possible way to save taxpayer money and increase efficiency.¹

Fire departments periodically purchase, occasionally using bond proceeds or through capital reserve funds, new equipment such as fire engines, pumpers, aerial trucks, miscellaneous trucks and ambulances/rescue trucks. Many volunteer departments also utilize bond financing or create capital reserve funds for the construction of new fire stations. Any time a fire district bonds or creates a capital reserve fund, voter approval via a mandatory referendum is required. However, voter turnout at such times is usually very poor and reportedly, heavily influenced by firefighters and their voting family members. The Lundine Commission staff cited one example:

“Newsday reported that when Coram Fire Department held a bond vote in 2000 to finance the biggest, most expensive firehouse on Long Island only 242 people voted. At less than 2% of registered voters, at least 138 of those votes were cast by department members or their relatives. The referendum passed, and the firehouse was built at the cost of \$7.7 million. Property tax revenues collected by the Coram Fire District were the eighth highest amount in the state in 2005 at just over \$5.4 million.²”

One of the findings of the Lundine Commission was that in cases of fire departments contracting with towns or villages in fire protection districts, the contracts vary in detail. Some contracts simply name a price for protection with little detail, documentation or support. The Lundine Commission recommended that in the interest of greater public information and transparency, towns “require that contracts with fire protection districts list categories of expenses so that officials and the public will have a better understanding of the costs for fire protection.” Our office concurs but takes this finding one step further, noting that this should only be an intervening, and interim measure towards greater transparency, efficiency, and reduced taxpayer expense. Therefore, we concur with the Lundine Commission’s recommend that all volunteer fire departments be required under State law to annually publish their detailed budgets, showing all revenues and appropriations, on the New York State Department of State’s Office of Fire Prevention and Control’s website, or alternatively, that Erie County offer to do so on the County’s website.

The Lundine Commission also recommended that local governments be required to “annually disseminate information on the costs for local fire protection, including the names and locations of fire districts and fire companies, their annual budget, and debt.” We agree with this recommendation, and note there is currently a widespread absence of transparency and openness in the reporting to the public of the cost of fire protection. We again note that this finding and recommendation also buttresses an argument for fewer fire departments and consolidation.

Lundine Commission Recommendation on Centralizing Fire Services

The Lundine Commission’s report recommended that local conversations and dialogues be held regarding “how fire and emergency medical services can best be provided and the volunteer system preserved, with the likelihood that some counties will move forward with restructuring initiatives.”³ Among the Lundine Commission’s recommendations was the centralization of emergency dispatch at the county level and local consideration and study of county level management for fire protection.⁴ The Lundine Commission made six (6) recommendations for fire protection and emergency medical services (“EMS”). Its first and only contentious recommendation stated:

The potential for moving to countywide management for fire protection and/or EMS should be reviewed in each county, with the goals of improving efficiency and service as well as preserving the volunteer system. If, after a fact-finding and public discussion period, county leaders decide that some level of management for fire protection, EMS, or both would be appropriate at the county level, they may promulgate a plan which would be subject to voter approval through referendum prior to implementation. If approved by the voters, the county would have broad powers to coordinate services and review equipment and coverage decisions made by local service providers. If desired, and approved by the voters, the county plan may include transfer of paid (career) fire or EMS employees to the county at the option of the municipalities with the paid or mostly paid staff.

Given the large number of often contiguous fire companies in Erie County and the resultant expense, both on town fire district property tax levies, as well as annual appropriations for paid and volunteer fire services in towns, villages and cities, we concur with the Lundine Commission's finding. Therefore, we recommend that the County initiate a dialogue with these municipalities and fire protection services to discuss ways to reduce expense and improve efficiency within the framework of the existing volunteer force.


