Dear Honorable Members:

The Erie County Comptroller's Office has completed an audit ("Audit") of the Erie County Department of Law ("Law Department") for the period January 1, 2005 to December 31, 2006. The scope of our audit was limited to expenditures of the Risk Retention Fund and the Law Department's Professional Services Contracts and Fees accounts and included a review of budget appropriations.

This Audit, performed in accordance with Generally Accepted Government Auditing Standards with the exception of a peer review every three years¹, included such tests of records, inquiries, and analyses as considered necessary under the circumstances.

The Audit's objective was to verify the accuracy and propriety of Risk Retention Fund and Law Department professional services expenditures and transactions, inclusive of the Risk Retention Imprest Account. Internal Control Procedures relating to cash receipts and disbursements are adequate. Specifically excluded from our Audit objective was assessment of the appropriateness of settlement payments.

No significant matters adversely affecting compliance with applicable laws, rules, and procedures came to our attention except as disclosed in this report. Our review was performed for the objectives previously described and would not necessarily disclose all instances of noncompliance with respect to areas of operation not reviewed.

BACKGROUND

The Erie County Attorney is responsible for the administration and operation of the self insurance, risk retention and loss prevention programs of the County.

The Law Department is headed by the County Attorney, who is appointed by the County Executive subject to confirmation by the County Legislature. The County Attorney is responsible for providing legal services to Erie County government including the defense of all negligence and medical malpractice claims, human rights cases, administrative hearings, arbitration and any other matters involving the County. The County Attorney is the legal advisor to the executive and legislative branches of County government including all County departments, offices, and independently elected officials. The County Attorney, within appropriations, appoints assistant county attorneys to perform duties to meet the responsibilities of the Law Department. This involves the rending of legal opinions to all elected officials and departments of County government in addition to the drafting of proposed state and local legislation. Staff members of the Law Department appear on behalf of the County in Family Court proceedings including juvenile delinquency and Persons In Need of Supervision ("PINS"). The County Attorney also provides legal assistance in the sale of properties foreclosed for failure to pay back taxes and administers the Indigent Defense Program.

The Erie County Legislature approves the annual budget and supplemental budgetary requests that set the appropriations available in a variety of accounts to support each county department's operations.

Expenditures are made in accordance with the provisions of the Erie County Charter and Administrative Code and established Erie County policies and procedures. Under the Charter, the Erie County Legislature is required to approve all contracts valued in excess of \$10,000.00. However, Erie County Administrative Code (the "Code") Section 6.02 (c) provides an exception with regards to Professional Service Contracts and Fees: "The county attorney may, within the limits of the appropriations provided therefore, employ special counsel, professional, technical or other consultant services and incur such expenses in connection therewith as he may deem necessary for the performances of his duties." Consequently, the County Attorney, in his/her professional judgment, is authorized under the Code to engage the services of legal and other professional firms. Through annual Budget Resolutions in the County's annual adopted Budget, the County Attorney is also authorized to retain and pay professional firms and to engage in litigation or to settle litigation brought against the County.

Payment of settlements and claims are generally paid from the County's Vendor Bank Account. In addition, the Law Department maintains a separate Imprest Account totaling up to \$50,000 to directly pay disbursements, settlements or judgments which are less than \$10,000 each.

In the County's Audited 2005 and 2006 financial statements, the total Risk Retention Fund expense recorded was \$722,428.32 (EXHIBIT I) and \$3,495,486.50 (EXHIBIT IV) respectively (accrual basis used).

The Law Department's Professional Service Contracts and Fees expenditures for 2005 were \$336,513.12 (EXHIBIT III) and \$159,598.45 in 2006 (EXHIBIT VI).

Expenditures from the Imprest Account were \$161,039.16 (EXHIBIT II) and \$181,857.34 (EXHIBIT V) for 2005 and 2006 respectively. It should be noted that expenditures for the Imprest payments are, for the most part, included as expenditures in the Risk Retention Fund since the Imprest Account is reimbursed from that Fund. The only difference between the amounts shown as Imprest Expenditures and Risk Retention reimbursements to the Imprest Account would entail timing differences which would be minimal.

SUMMARY

For the two-year period we noted:

- The County paid \$1 million in 2005 and \$1.5 million in 2006 for legal services provided by outside counsel to represent the County in certain litigation suits against the County.
- Following this office's Risk Retention Audit dated January 2001, supervisory procedures were still not formalized to ensure that payments are recorded properly in the County's financial accounting system.
- Mileage and Travel Reimbursement payments to County employees were not made in accordance with the established Erie County policies and procedures.
- There are no written policies and procedures with regards to mileage and travel reimbursement payments to non-employees (witnesses).
- Independent contractors hired by the Law Department were consistently paid for hours worked in excess of their allowable hours as stated in their contracts.
- The cash accounting program used to administer the Imprest checking account is underutilized to record payments on SAP.
- There are no written policies governing how the Law Department can make payments out of the Risk Retention Fund or the department's Professional Services account.
- The County has under budgeted appropriations in the Risk Retention Fund in the 2005, 2006 and 2007 budgets. To correct this, the County later appropriated additional funds in mid-year.
- There is no central control to administer, monitor and maintain the purchase of insurance policies for Erie County and there are no written procedures and policies with regard to the acquisition of those policies.

- The County expended \$421,838.75 from the Risk Retention Fund and \$26,656.77 from the Law Department's professional services account to defend itself in litigations related to the 2005 Budget. All payments were to two law firms.
- The County expended \$168,178.47 from the Risk Retention Fund to pay the four law firms hired by the County Sheriff, County Comptroller, County Clerk and District Attorney in their 2005 Budget lawsuits against the County Administration.
- The County expended \$39,097.04 from the Risk Retention Fund and \$6,079.65 from the Law Department's professional services account to defend itself in various Aurora Barn Department of Public Works litigations.
- The County expended \$8,430.90 from the Risk Retention Fund to pay one law firm in regard to the Buffalo Office Interiors matter.
- The County expended \$49,693.67 from the Risk Retention Fund and \$51,412.70 from the Law Department's professional services account on Erie County Medical Center ("ECMCC") related litigation. All payments were to two law firms.
- The County expended \$53,934.05 from the Law Department's professional services account to pay for the services of two law firms relating to the Erie County Fiscal Stability Authority ("ECFSA").
- The County paid \$22,732.04 from the Law Department's professional services account to two firms for lobbying services.
- The County paid \$35,000 from the Law Department's professional services account to one law firm for services concerning the removal of local toll booths.
- The County paid \$8,576 from the Law Department's professional services account to one law firm for services relating to the city-county merger.

FINDINGS AND RECOMMENDATIONS

A. RETENTION OF OUTSIDE COUNSEL

Our disbursement review identified that a number of law firms as shown in Figure 1 were paid \$1,034,257.93 in 2005 and \$1,518,118.39 in 2006 for settlements/judgments and services rendered on behalf of Erie County or Erie County officials. (See Figure 1)

An examination of contracts revealed that the previous County Attorney issued a Request for Proposal ("RFP") on June 16, 2000 to identify law firms that would be pre-qualified to provide general counsel in a wide range of areas of law to the County of Erie and/or the Erie County Medical Center. Competitive bidding requirements under General Municipal Law §103 and §104 for political subdivisions provide for the promoting of public interest to guard against favoritism, improvidence, extravagance, fraud and corruption and to assure the prudent and economical use of public moneys for the benefit of all taxpayers.

Below is the listing of law firms that were pre-qualified or were used as outside counsel in 2005 and 2006. All but two of these firms were pre-qualified to provide services to Erie County through an RFP.

We note that the law firm Lipsitz, Green, Farhringer, Roll, Salisbury & Cambria (now known as Lipsitz Green Scime Cambria LLP) did not respond to the RFP and was not pre-qualified to represent Erie County or ECMCC. As noted in Figure 1, the County paid settlements and fees totaling \$874,730.01 to Lipsitz Green. Of that sum, \$836,501.07 was paid as settlements to non-County employees suing the County for damages. The remaining \$38,228.94 was related to the Aurora Barns matter for representing current or former County employees suing the County. Due to the "conflict of interest" issues for the County, such employees were allowed to choose his or her own attorney/consultant pursuant to Section 18 of the NY Public Officers Law and prior Erie County Legislature resolutions.

In addition, the law firm Hurwitz & Fine PC did not respond to the RFP. They were chosen by the County Attorney to provide legal services relating to the County Administration's relationship with the Erie County Fiscal Stability Authority. Hurwitz & Fine PC was paid \$51,449.05 for such legal services in 2006.

In November 2005, the Erie County Comptroller's Office, pursuant to an Order and Judgment of New York State Supreme Court Justice Joseph G. Makowski, paid out \$168,178.47 in legal fees to the four law firms representing County elected officials Frank Clark, Nancy Naples, David Swarts and Patrick Gallivan in their litigations against Erie County related to the County's 2005 Budget (see Auditor Comments for further details.) At that time there were insufficient budget appropriations available to fund these payments. However, the Law Department, citing General Municipal Law §70, stated that such payment should be made by the treasurer or other County finance officer regardless of whether there is a specific appropriation, if the money is in fact available.

Excluding settlements paid, the County Attorney has reduced fees paid to outside firms over the span of our audit.

Other Litigation

There are instances where the Erie County Law Department cannot represent County employees or former employees when they initiate legal actions against the County. These situations create a conflict of interest for the Law Department. The employee or former employee must select outside counsel to represent their interests. Secondly, there are certain litigation matters where the County Law Department does not have the necessary legal expertise to properly represent the County. In these instances, the County Attorney uses professional judgment and hires outside counsel to defend the County. The below items summarize significant, high-profile, cases where expenditures were made to outside law firms during the period of our audit. Details of the payments and litigants are provided in Exhibit VIII.

The investigation of allegations concerning activities at the Erie County Highway Department Barns in Aurora, New York resulted in criminal prosecution by the District Attorney. In conjunction with those allegations and charges, actions were brought against the County by employees resulting in the County paying the firms of Lipsitz Green et al. and Thomas H.

Burton, Esq. \$38,228.94 and \$5,922.00 respectively to represent employees of Erie County in civil matters. In addition \$1,025.75 was paid to Lori L. Strong for reporter/transcript services.

Buffalo Office Interiors ("BOI") sold Erie County furniture and provided other services to Erie County. It was alleged that Erie County was overcharged for these goods and services. The County paid the firm of Hodgson, Russ LLP \$8,430.90 for services relating to excessive payments for office furniture. On August 16, 2006, a Supreme Court ordered settlement was approved and BOI is paying Erie County \$225,000 over five years.

During the period of our audit, Erie County suffered severe budget reductions, referred to as the "Red and Green Budgets." As a result of these reductions, the County was taken to court by some individuals, several unions and some elected officials. In order to defend itself, the County retained the firms of Harter, Secrest & Emery LLP and Magavern, Magavern & Grimm. These firms were paid \$281,573.65 and \$166,921.87 respectively.

Also during the period of our audit, the County Law Department was unable to defend the County on certain matters related to the County Budget, and yet advocate for certain elected officials on those same matters. In order to act for these local elected officials, the individual officials hired their own representation, as per the Erie County Charter and certain resolutions. The County paid the law firms of Hodgson, Russ LLP \$68,709.75 to represent the District Attorney, Bouvier Law \$58,033.63 to represent the Sheriff, Sullivan, Oliverio & Gioia \$28,860.09 to represent the County Clerk and Dennis C. Vacco, Esq. \$12,575.00 to represent the Comptroller for a total of \$168,178.47.

Other matters for which the County hired outside legal assistance included the possibility of a City-County merger. Magavern, Magavern & Grimm was retained to render legal advice with regard to City-County merger issues. The County paid \$8,576.00 for this service.

During the period of our audit, Erie County came under the oversight of the ECFSA. The County paid the firms of Hurwitz & Fine LLP and Damon & Morey LLP \$51,449.05 and \$2,485.00 respectively for legal services pertaining to actions taken by the ECFSA.

Legal services relating to the Sale, Purchase and Operations Agreement ("SPOA") between the County and ECMCC caused the County to pay the firms of Magavern, Magavern & Grimm and Damon & Morey LLP \$97,711.37 and \$3,395.00.

The firms of Featherstonhaugh Conway and Bolton-St John, Inc were paid \$3,166.66 and \$19,615.38 respectively for services relating to NYS legislation.

The County paid Phillips Lytle LLP \$35,000.00 for legal services relating to the removal of toll booths on the Niagara section of the NYS Thruway.

We recognize the existence of a well-established exception to competitive bidding requirements for professional services such as legal services, especially in areas where specific expertise in the subject matter is required. However, we believe that RFP's should always be conducted to prequalify law firms to provide services to Erie County. Such a pre-qualified list of firms with

expertise in litigation in a variety of areas of law allow the County Attorney, in his or her professional judgment, the ability to choose the firm best qualified to represent the County.

WE RECOMMMEND that the Law Department continues the practice of issuing an RFP to develop a list of pre-qualified law firms and that such lists be utilized and that an RFP be issued, at minimum, every three to four years to refresh the list of qualified firms.

WE FURTHER RECOMMEND that the Law Department utilize that list for the retention of outside counsel and avoid, whenever possible, retaining firms that are not pre-qualified.

To determine if a contract, engagement letter or retainer letter was on file, we selected a sample of fifteen (15) cases assigned to eight (8) law firms. Of that sample, only Lipsitz Green had not responded to the RFP. Consequently there is no estimate of hourly rates on file for that law firm. This firm handles only Erie County conflict of interest cases.

In response to our request, the Law Department provided only seven (7) contracts, engagement letters or retainers to support retention of outside counsel. As a result, we identified that only forty-seven percent (47%) of the litigation cases assigned to outside counsel had an engagement contract, letter or retainer with the County. The Law Department's apparent failure to have a document establishing a relationship with these firms and agreeing to payment terms in advance of the entering into of any relationship is inconsistent with County contracting policies.

Although seven (7) of the eight (8) firms were pre-qualified pursuant to the RFP, the RFP itself does not constitute a contract but merely an offer to provide services at a set rate.

WE RECOMMEND that the County implement policies and procedures to ensure that whenever the County retains outside counsel or a consultant, regardless of whether that party has been or is retained by the County on another matter, that a contract, engagement letter and/or a retainer confirming the assignment to outside counsel and specifying the hourly rates to be charged should be on file.

B. MILEAGE AND TRAVEL REIMBURSEMENT

Our review of the Imprest Account payments for 2005 and 2006 included ten (10) payments for mileage and travel. Nine (9) of the payments went to County employees and one payment went to a non-employee witness. All ten (10) of the reimbursement requests were accompanied by departmental check request forms. The ten (10) sample items reviewed were broken down as follows: three (3) items included payments for mileage only, two (2) items were for parking only, two (2) other items were for airfare only, and the last three (3) items were for other travel related expenses, two (2) of which included mileage. Four (4) of the five (5) mileage payments were to County employees in 2006 and were paid at the rate of \$0.445 per mile. The fifth mileage payment went to a non-county employee in 2005 and was reimbursed at the rate of \$0.405 per mile. Erie County uses the standard mileage rate set annually by the Internal Revenue Service ("IRS") for mileage reimbursement to employees. We confirmed that all mileage payments were based on the appropriate prevailing IRS rate.

For one (1) reimbursement involving a person other than an Erie County employee, there was no receipt found for tolls and payment was made for both gas and mileage. The payment for both gas and mileage was inappropriate, as the mileage reimbursement rate set by the IRS covers both. In addition, a reimbursement of \$87.00 was paid for three (3) meals. The Comptroller's Accounting Prescription (CAP210-1), County Travel Policy and Prescription governing meals reads as follows: "In terms of both necessary and reasonable, reimbursement for meals, excluding alcoholic beverages will be allowed up to a maximum of \$25.00 per day." While there is no existing County policy for reimbursements to non-county employees, the cost of these meals appears excessive based on the County reimbursement rate for County employees of \$25.00 per day.

We note that one (1) County employee was reimbursed for the cost of hotel, mileage and tolls without having receipts for the tolls or the completed County mileage form.

In violation of the meal policy, a second County employee was reimbursed for meals in excess of the County maximum. Reimbursement was made for two (2) meals on October 23, 2006 for \$64.05 and two (2) meals on October 24, 2006 for \$49.86.

We believe that because the Law Department occasionally makes travel and mileage reimbursement payments to witnesses that are not County employees, there should be written policies and procedures to follow regarding travel, mileage and lodging reimbursements that could be applied county wide for non-County employees. The policy could be as simple as acknowledging that they will apply the same rules used by County employees set forth in CAP210-1, Chapter I Section 13 and Chapter X Section 20 of the Erie County Personal Policies and Procedures, and Sections 38.1 and 38.2 of the Collective Bargaining Agreement between the County and the Civil Service Employees Association.

Please see the section entitled "Results of Exit Conference" for the County Attorney's comments on this section during the Exit Conference.

WE RECOMMEND that the Law Department follow the applicable rules and regulations for travel and mileage reimbursements for employees.

WE RECOMMEND that the Law Department recoup the overpaid meal reimbursements from County employees.

WE FURTHER RECOMMEND that the Law Department develop written procedures for nonemployees that are similar to those that apply to county employees for travel and mileage reimbursements.

C. INDEPENDENT CONTRACTOR CONTRACT ANALYSIS

Our review of the Imprest Account included payments to six (6) people that were paid for hours worked as independent contractors. Four (4) of the independent contractors were former County Attorney employees, one (1) was a former ECMCC employee and the remaining one (1) was never a County or ECMCC employee. Each had their own personal contract, and in some

instances multiple contracts with the Law Department. Four (4) of these contracts took place in 2005 and two (2) in 2006.

Four (4) of the contracts were based on working a maximum number of hours per day and week, while the other two (2) were based on a maximum dollar payment level per month. Of the four (4) contracts based on hours worked, one (1) contract was followed with no instances of exception while the remaining three produced the following instances of non-compliance:

- Contractor's <u>daily</u> hours worked exceeded the maximum allowed per the contract 65% of the time (222 of 343 days) with the worst offender averaging 70% higher than allowed.
- Contractor's <u>weekly</u> hours worked exceeded the maximum allowed per the contract 20% of the time (16 of 81 weeks) with the worst offender averaging 28% higher than allowed.
- One contractor had one instance (out of 25 total days worked) of working a Monday while the contract stated the work week to be Tuesday through Thursday.

The contracts that were based on an aggregate monthly payment of \$5,000 had one (1) exception to their terms. There were two (2) instances where the monthly payment exceeded the \$5,000 limit. The first instance was for a payment that was arranged ahead of time using a contract amendment since the contractor worked well below her limit the preceding month. The second instance had no such amendment and was therefore in non-compliance with the contract. We found that even though two monthly payment totals exceeded the \$5,000 limit, the totals paid over the life of the contracts did not surpass the contract limits.

All payments made by the Law Department to the independent contractors, some of whom were former County employees, including laid-off employees, were reported to the Comptroller's Office for 1099 reporting purposes and the 1099s were mailed accordingly.

As a result of our review, we have identified several other related issues:

- A universal time sheet was not used for all the contractors.
- During the 29 week period dated April 11, 2005 through October 27, 2005, one consultant's timesheet recorded an unpaid lunch on 92% of the days when she worked at least five (5) hours. During the subsequent eight (8) week period dated October 31 through December 22, 2005, that rate in which lunch was recorded dropped to 23%. Since the independent contractors do not get paid for lunch hours, management should ensure that they are recording all instances when a lunch break is taken.
- It should be noted that the Law Department issued their own legal opinion on June 10, 2005 stating that "... it was proper for the Law Department to hire ex-employees as independent consultants...". In addition, the opinion further says that the consultants "...were only asked to perform certain specific tasks and their hours of work were not regulated by the department head." However, this Audit notes that some of the consultants contracts specifically state the daily maximum number of hours to work and which days to work.

WE RECOMMEND the Law Department review the working arrangements of each independent contractor to ensure that all legal definitions regarding independent contractors are met to prevent future sanctions by the IRS and/or the Social Security Administration.

WE FURTHER RECOMMEND that the Law Department ensures that all contracts are being adhered to and that all instances where lunch is being taken are also being recorded on the time sheets.

D. BUDGET

Our examination of budget transactions for 2005 and 2006 also required a review of budget transactions for the fiscal years 2004 and 2007. We found that no appropriation for Risk Retention expense was provided for in the Annual Adopted Budgets for 2004 and 2005. The Annual Adopted Budget appropriation for the years 2006 and 2007 was \$1,500,000 and \$1,000,000 respectively.

We identified that in each of the four (4) years, supplemental appropriations were approved by the Erie County Legislature at the request of the County Administration. The results of our examination for each year are as follows:

Fiscal Year 2004

On July 8, 2004 the County Legislature approved 2003 Year-End Budget Balancing Amendments (Comm. 9E-65) which designated \$3,000,000 of the 2003 fund balance for "Judgments and Claims" against the Risk Retention Fund. It should be noted that the designation is a non-binding commitment of fund balance. The purpose can be changed at any time prior to it being appropriated by the Erie County Legislature. Included in the resolution were additional clauses inserted by the Legislature, two of which effectuated immediately and for all future years, a policy that allows no changes or rollovers of the designated fund balance without the prior formal approval of the Erie County Legislature.

While Comm. 9E-65 approved the designation of fund balance for the Risk Retention Fund, we could not confirm that a subsequent resolution, authorizing the appropriation of the designation, was approved by the Erie County Legislature. The wording of the resolution is specific as to the establishment of a Fund Balance designation in 2003 yet omits mentioning that approval has been given to appropriate such designated fund balance in 2004. The language of the policy change in the resolution does not support the consideration that the intent of the legislature was to authorize the re-appropriation of the designated fund balance in 2004 without a second resolution.

Of the \$3 million budgeted we identified that cash disbursements were \$1,180,852.98, net of a prior year accrual of \$10,000, leaving an unspent balance of \$1,819,147.02. Of this amount, using appropriate accounting and reporting guidance, an expense accrual totaling \$1,811,000 was charged to 2004. This transaction thus provided the funding mechanism to make cash disbursements of Risk Retention funds in 2005.

WE RECOMMEND that any resolution relating to the designation of fund balance be very specific as to the intent of the Legislature's approval. It should specify if the designation made in the prior year is also authorized to be appropriated or re-appropriated in the subsequent year if that is the intent of the Legislature. Without such wording, the appropriation of designated fund balance must be approved by the Legislature via a separate resolution.

2005 Fiscal Year

On December 1, 2005 the County Legislature approved Departmental Year-End Budget Transfers for 2005 (Comm. 28E-17) which included an increase of \$3,000,000 for "Insurance Charges" funded by a corresponding decrease of County expense in the MMIS Medicaid Local Share account. We noted no discrepancies with the resolution.

Of the \$3 million budgeted we identified that cash disbursements were \$1,800,852.57 and net of the prior year accrual of \$1,811,000, left an unspent balance of \$3,010,147.43. Of this amount, using appropriate accounting and reporting guidance, an expense accrual totaling \$732,575.75 was charged to 2005. This transaction provided the funding mechanism to make cash disbursements of Risk Retention Funds in 2006. The result of these transactions was an unspent budget of \$2,284,971.68. We confirmed that the County's 2005 Financial Statements contained a designation of fund balance totaling \$2,267,424.25.

However, on June 8, 2006 the County Legislature adopted Comm. 10E-3 which included an authorization to designate \$2,867,425 of the 2005 fund balance within the Risk Retention Fund. This amount is \$600,000 greater than the actual amount recorded on the County's 2005 Financial Statements. The original amount of \$2,867,425 recorded in the County's SAP accounts on February 15, 2006 was based on the actual unspent budget of the Risk Retention Fund available at December 31, 2005. Subsequent to the resolution's adoption a year-end audit adjustment in the amount of \$600,000, confirmed by the County's independent auditors, was recorded on the County's accounting system on June 28, 2006. However, the controlling budget accounts were not adjusted consequently providing an additional \$600,000 budget appropriation to the Risk Retention Fund. The Division of Budget, Management and Finance was notified of the change but has failed to make the required adjustment entry. The Legislature was/is unaware the Risk Retention fund had these additional funds. Consequently, the budget entries on SAP were not authorized by the Legislature.

(Recommendations for 2005 are combined with 2006 and are listed below.)

2006 Fiscal Year

The 2006 Adopted Budget contained a \$1,500,000 appropriation for the Risk Retention Fund.

On December 14, 2006 at the request of the County Administration, the County Legislature approved 2006 Year-End Budget Balancing Amendments (Comm. 25E-14) that provided an additional \$1,500,000 appropriation to the Risk Retention Fund.

We identified additional budget entries made by the County Administration increasing the 2006 Risk Retention appropriations by an additional \$3,150,000 due to the January 2006 Tobacco secondary financing. Consequently \$9,026,374.25, including \$8,950.00 of encumbrance reserves, was available for Risk Retention expenditures in 2006. The 2006 net expenses totaled \$3,495,486.50 leaving an unexpended balance of \$5,530,887.75. (See EXHIBIT VII)

On May 17, 2007, the County Legislature approved 2006 Year-End Budget Balancing Amendments (Comm. 9E-8) which designated \$2,530,887 of 2006 funds to the Risk Retention Fund for re-appropriation.

The designation amount is \$3,000,000 less than the available balance and we confirmed that this \$3,000,000 appropriation lapsed and became part of the County's Undesignated Fund Balance at December 31, 2006.

EXHIBIT VII is a comparative summary of Risk Retention Fund monies spend for the period January 2005 through December 2006.

WE RECOMMEND that the Division of Budget, Management and Finance confirm that the amounts approved by the Legislature for the Risk Retention fund match the budget appropriation.

E. IMPREST ACCOUNT

The Law Department maintains an Imprest Account to expedite payments for litigation fines, fees, settlements and judgments and various minor expenses typical of a petty cash fund. An Imprest Account is defined as a petty cash control mechanism in which an individual is given a fund of money (imprest) to meet certain expenses. When a portion of the money has been spent, the individual submits vouchers and the fund is replenished.

The Law Department has an established policy allowing for the Imprest Account to pay settlements and judgments and other litigation expenses in amounts not exceeding \$10,000. Payments in excess of \$10,000 must be made out of the County's Vendor Bank Account. The Law Department uses "Quicken" financial software to process Imprest Account transactions and generate checks.

Our examination of Imprest Account transactions found that there were no instances where payments exceeded \$10,000 and that monthly bank reconciliation reports were on file in the Comptroller's Office. No material discrepancies were detected in our review of Quicken transactions.

Replenishment payments from the County's SAP accounting system and the corresponding deposits to the Imprest Bank Account were traced and verified. However, a reconciliation of expense postings on SAP to the payment detail recorded on Quicken could not be fully completed because the category structure of the transactions did not readily match the account class originally assigned in the replenishment requests. For example, a replenishment request of Quicken payments categorized as "Travel and Mileage" should have been classified on SAP as

account 555020, "Travel & Mileage-Litigation", but was instead recorded on SAP in account 555030 "Litigation Disbursements."

Our review finds that the Imprest Account Administrator spends an inordinate amount of time manually creating bank reconciliations and reports to support replenishment requests. We found that Quicken's built-in reconciliation feature has never been used since the Law Department began using the software in 2001. As a result, there is \$1,534.02 of stale dated checks issued prior to January 2006 that should be voided.

WE RECOMMEND the utilization of the class feature to assign the SAP account numbers to all disbursements at the time of check issuance and the creation of data uploads to SAP to record expenditures and request replenishment payments. The creation of data uploads should be done with the assistance of the County's Division of Information and Support Services ("DISS")/SAP programmers and the Comptroller's Office accounting staff. Implementing the above recommendations will reduce the time expended by the Account Administrator to manage the Imprest Account.

WE RECOMMEND that the Law Department immediately utilize SAP to allow the creation of an Imprest Bank Account that would replace Quicken and effectively eliminate the need to record the transaction twice. Currently, it is recorded once on Quicken to generate the check and again on SAP to record the expense and request a replenishment check.

WE RECOMMEND the write-off of \$1,534.02 of stale dated checks on the Quicken system and a corresponding SAP entry to record the recovery of prior year expense.

F. INSURANCE

On July 6, 1978 the County Legislature approved a resolution (Comm. 12D-12) declaring that Erie County is self-insured. That resolution also directed that the County Attorney shall "establish, administer and operate a program of risk management for the administration, investigation, compromise, defense and payment of automobile and general liability claims and the administration of such necessary services in connection therewith as loss prevention, investigation and adjustment of claims, actuarial services and risk management evaluation services." At that time the County maintained a Supervisor of Insurance, a county position that no longer exists.

Our examination of insurance premium payments included, for comparative purposes, expenditures in 2004, 2005 and 2006. It should be noted that there was a substantial decrease of \$238,107.33 in expenditures for property insurance from 2004 to 2005 and 2006. The decrease in expenditures in 2005 and 2006 was found to be both the result of the removal of the Erie County paid insurance coverage for the Erie County Home and ECMCC as well as a general drop in insurance rates throughout the industry. This insurance coverage is now paid by ECMCC itself.

Further examination revealed that the Law Department, as the responsible department for the administration of the County's risk and insurance program, was unaware of the existence of a

number of insurance policies. Listed below are two (2) summary schedules of expenditures for insurance premiums reported on SAP. The first is from the Risk Retention Funds and the second shows the expenditures made by various other departments.

We found that payments listed for Municipal Insurance Consultants Inc. are not insurance premiums; rather, they represent contractual fees for providing general risk management services.

WE RECOMMEND that payments to Municipal Insurance Consultants, Inc. be recorded in the Law Department's SAP Account 516020 - Professional Service Contracts and Fees rather than as SAP Account 555050 - Insurance Premiums.

Our Audit found that four (4) departments make payments for insurance premiums: the Department of Environment and Planning (fund center 163, and the Division of Sewerage Management, fund centers 181, 182, 183 and 186), Department of Public Works (fund center 122), Department of Health (fund center 127), and the Buffalo and Erie County Public Library (fund center 420).

The insurance carriers listed in the above Figures 2 and 3 carry insurance policies for various County entities as follows: Lawley provides insurance to the Erie County Tobacco Asset Securitization Corporation that covers directors and officers liability. McManus Peard Gesl provides insurance to Erie County for employee theft. Northeastern Agencies provides Erie County with excess workers compensation and employee liability. Scott Danahy Naylon Co. Inc. provides insurance coverages for Erie Community College, ECMCC and the Buffalo and Erie County Public Library. Vanner Insurance Agency provides insurance for the Erie County Stop DWI Program, Ralph Wilson Stadium and the Erie County Botanical Gardens. CIMA Companies provide insurance covering volunteers working for various Erie County programs. First Niagara Risk Management Inc. provides insurance coverage for the Erie County Sewer Districts. Nathan Lane Agency Inc. provides coverage for the Southtowns Advanced Wastewater Treatment Facility.

The fact that the Law Department has little or no knowledge of certain insurance premiums being paid by other departments re-enforces the intent of the legislative resolutions that the County Attorney administer and operate the programs of self insurance, risk management and loss prevention for Erie County. We obtained information from departmental sources indicating that insurance policies within their departments are required by grant sponsors in order to qualify for program funding.

WE RECOMMEND that the County implement procedures to ensure that the Law Department is informed of all insurance policies purchased with County funds.

WE RECOMMEND that the Law Department develop and maintain a database to include a history of claim activity for each insurance policy purchased with County funds.

WE RECOMMEND that internal department policies and procedures relating to the payment of claims and settlements should be written to assist staff to ensure the proper accounting, recording and categorization of Risk Retention Fund expenditures.

Our review included testing for compliance with Erie County Purchasing Policies and Procedures relating to the bid procurement and RFP process.

We reviewed the documentation used in the selection of a vendor to provide risk management services to Erie County, including the management of the bid process for insurance underwriting. We found that three local firms were solicited by the Law Department and only one vendor, Municipal Insurance Consultants, Inc ("MIC"), responded to the RFP. MIC was awarded the contract by the Law Department. We question why an RFP with a wider search process was not conducted.

The Law Department could not provide documentation to confirm that bids or RFP's were issued prior to the selection of insurance carriers and brokers. Further inquiries were made to MIC to verify if policies and procedures for bids and RFP's complied with established County purchasing policies and procedures. Their response outlined that their services, as contained in their contract with the County, include identifying and quantifying property and casualty

exposure, reviewing contract language for insurance, working with vendors and the Law Department to ensure compliance with insurance and risk management issues, preparing insurance and underwriting data specifications, managing the bid process and providing continuing review of current insurance policies and coverage limits. Citing the complexity of the insurance industry and various loss exposure scenarios, an RFP generally requiring the selection of the lowest cost responsible bidder is too restrictive. If modifications are required because of an insurance carrier's varying coverage criteria, a new RFP would be required. However, competitive bidding would allow for MIC to challenge coverage costs and have the bidders refine and recalculate their bid proposals to achieve the lowest cost without having to initiate a completely new bid or RFP. MIC does acknowledge that when conditions exist where insurance coverage is very specific with little or no variations, an RFP can be used to solicit bids.

We find that although MIC is not required to abide by Erie County's Purchasing and Bid procedures, it does in-fact, as industry specialists, provide the oversight and evaluation services similar to and greater than the Erie County Director of Purchase to ensure that the County obtains the most beneficial insurance coverage at the least amount of cost.

Of the six (6) insurance coverage renewals reviewed by MIC, two (2) were for county-owned property, one (1) for directors and officers liability for the Erie Tobacco Asset Securitization Corporation that were renewed with the incumbent agency and carriers with no RFP or bid request issued to other agencies. RFP's were issued for Sewer District and Erie Community College insurance coverage. Relative to the Buffalo and Erie County Public Library's Rare Books insurance coverage, a RFP was deemed unnecessary because of the limited market selection of carriers providing such coverage.

WE RECOMMEND that a consistent policy be established by the Law Department and MIC to define the procedures required to be followed for the purchase of insurance coverage. Considering insurance industry business practices and the complexity of insurance coverage, the policy should be written to provide guidance to determine when and where an RFP should be issued and in the alternative, when competitive bidding should be engaged. Such policies and procedures should be on file with the Erie County Division of Purchase.

WE FURTHER RECOMMEND that the Law Department designate that the County Department of Personnel's Risk Manager assume the duties necessary to become that single point of contact for the insurance consultant and county departments to manage and control the risks and associated costs of the County's Workers Compensation and General Insurance programs.

AUDITOR COMMENTS

Through their professional services account, the Law Department subscribes to the Westlaw online research service in which they pay for subscriber access based on the number of passwords used. Included with the Law Department are users from the Sheriff's Office, County Legislature, ECMCC and Department of Environment and Planning. The Law Department stated that although the Law Department pays the fees for other departmental users, there is a benefit to the Law Department because the other customers are almost all attorneys and are able

to, in many cases, get enough information through the online research so that they do not need to utilize the Law Department's Attorneys for case research. As such, this is a symbiotic relationship that benefits all related parties thus justifying the Law Departments responsibility to pay for all users. In addition, the cost of the seven (7) non-Law Department users is nominal.

* * * * *

While working on site during the course of our Audit, the network at the Law Department crashed three times causing our loss of unsaved work on two of those instances. We were told by Law Department staff that this was not unusual and that the network had crashed numerous other times during our Audit. About six (6) years ago the server for the Law Department crashed and they were told by DISS that they either had to buy a new server or switch to the CITRIX network, which the County would be eventually using. Ever since that time there have been problems. Recently there have been a group of people that have been taken off the CITRIX network and connected to the County's network through Windows XP. This has caused the additional problem in that WordPerfect is not working properly. WordPerfect is used by the Law Department since it is very "attorney friendly" and is used by many law offices. DISS has advised the Law Department to update to a more current version of WordPerfect which should fix the current problem of incompatibility with Windows XP. This will be expensive in that a site license will cost about \$500 per user. The Law Department may have to limit the number of users for this reason.

* * * * *

During the County's 2005 Budget crisis, numerous lawsuits were brought against the County by various parties, including County elected officials, the Board of Elections, ECMCC, and the AFSCME, CSEA and Teamsters bargaining units. According to Section 18 of the New York State Public Officers Law, when there is a conflict of interest that prevents the County from representing an employee, in this case an employee suing the County, the employee is able to retain their own attorney, with the only requirement being that the attorney's rates are reasonable. In all there were about thirteen (13) separate lawsuits filed against the County which were represented by six (6) different law firms. The County Attorney chose to retain outside counsel due to a potential conflict of interest against County officials as well as to take advantage of their expertise as is explained both above and below.

* * * * *

Our testing included a review of payments made from the Risk Retention Accounts and the Professional Services Contracts and Fees, SAP Account 516020. Risk Retention included the following SAP Accounts: 555000-General Liability, 555010-Settlements and Judgments Litigation, 555020-Travel and Mileage Litigation, 222030-Litigation Disbursements, 555040-Expert/Consulting Fees Litigation, and 555050-Insurance Premiums. Our testing for the Professional Services Contracts and Fees included a review of payment authorizations, check request forms and contracts or engagement letters for each payment. For Risk Retention, in addition to the previously mentioned, we looked at settlement agreements. The review of 163 payments found that only twelve (12) had no departmental check request form, however all

twelve (12) did have a payment authorization signature on the invoice itself thus showing evidence of review and approval. The risk payment folders had all of the applicable settlement agreements. It appears that controls over payments made from the Risk and Professional Services accounts are tight and much improved from the time of the previous Risk Retention Audit dated January 2001.

The 2001 Audit recommended the development and implementation of supervisory and other procedures to ensure that payments; were properly authorized, complied with County procurement policies and procedures, and were timely. The Law Department has implemented procedures to address those recommendations; however department policies and procedures were still not formalized and written. Internal department policies and procedures relating to the payment of claims and settlements should be written to assist staff to ensure the proper accounting, recording and categorization of Risk Retention expenditures are made.

OTHER OBSERVATIONS

The 2007 Adopted County Budget included a 2007 appropriation for \$1,500,000 for the Risk Retention Fund. On May 3, 2007, upon a request of the County Administration (Comm. 7E-16), the Legislature approved an additional appropriation of \$3,000,000 to the Fund using "unanticipated" 2007 revenue from ECMCC. As a result, the balance in the Risk Retention Fund as of August 1, 2007 was approximately \$4.9 million.

As an independent contractor, after he had been laid-off in March 2005, a Comptroller's Office employee, Eugene Przespo, performed a reconciliation of the Imprest account (Exhibit II). Mr. Przespo returned to the Comptrollers Office in early 2006. He did not participate in this audit.

RESULTS OF EXIT CONFERENCE

An exit conference was held on Friday, August 24, 2007 with the County Attorney and members of his staff. The contents of this report were discussed and the County Attorney indicated general agreement with our findings and recommendations.

One area where no agreement occurred was the area of mileage and travel reimbursements. The County Attorney believes that the "County reimbursement rate may not be appropriate for some non-County persons." When asked about this, he specifically mentioned expert witnesses retained by the County.

The County Attorney also takes exception with Section C, Independent Contractor Contract Analysis. He was quick to point out that no contract had exceeded a contract limit, a point with which we agree. The County Attorney believes that outside contractors working with his department deal with situations, such as absolute and unalterable deadlines, that demand flexibility.

The County Attorney also asserts that the Legislature has tasked the Law Department with the former responsibilities of Erie County's Risk Manager. These responsibilities include monitoring Erie County's insurance coverage. The County Attorney does not believe this is an appropriate responsibility for the Erie County Law Department.

In accordance with the County's Audit Response System and Procedures, we request that the County Attorney prepare a written response to our office and the County Executive concerning the findings and recommendations. A draft of this written response should be submitted to the Division of Budget, Management and Finance for review and approval prior to its submission to the County Executive. The final written response should be submitted to our office and the County Executive by September 28, 2007.

We further request that the County Attorney forward copies of the response to the Erie County Legislature and the Erie County Fiscal Stability Authority by September 28, 2007.
